UNFINISHED BUSINESS

ARSL conference summary was given by Brenda Tillis, Kenneth Miller and Gail Bazinet. They all enjoyed the conference and was very thankful that they were able to attend; they brought back so much information to share with the Allen Parish Libraries team and Board Members.

At the October 2021, the Allen Parish Libraries employees requested a 2022 one-time cost of living adjustment based on setting and attaining three measurable goals through October 2022.

Admin Staff Ashley Weaver and Chalanda Wilson presented the 2022 measurable goals in the October 21, 2021 board meeting. All goals were met and some exceeded the five or ten percent that was set in the October 21, 2021 board meeting. (see attachment of validated attainment of goals)

After the discussion and evidence of the 2022 measurable goals, and the hard work and dedication of the staff. Fran Jordan motioned that a one-time cost of living adjustment of \$3000.00 be given to each full-time staff and \$1000.00 be given to each part-time staff in November 2022.
